Admission to B.A.LL.B.(Hons.) & B.Com.LL.B.(Hons.) Degree Course for the Academic Year 2018-2019

under Non-Resident Indians (NRI) / Overseas Citizens of India (OCI) Quota

 Applications are invited from eligible candidates for admission to B.A.LL.B. (Hons.) & B.Com. LL.B. (Hons.) Degree Course offered by Tamil Nadu National Law School, Tiruchirappalli-620027 for the academic year 2018-2019, under Non-Resident Indian(NRI) Quota/Overseas Citizens of India(OCI).

2. Total number of Seats – 6

- (i) B.A. LL.B.(Hons.) 3
- (ii) B.Com. LL.B.(Hons.) 3

3. Eligibility Criteria

Admission to the NRI/OCI quota will be made in the following order and as per merit on the basis of marks secured by the candidates in the qualifying examination (10+2 or an equivalent examination). The candidates seeking admission under NRI / OCI quota should have secured not less than 60% marks in aggregate in the qualifying examination. The marks obtained in the 10+2 or an equivalent examination excluding language subjects shall be reckoned for deciding inter-se merit. [CANDIDATES SEEKING ADMISSION UNDER NRI/OCI QUOTA NEED NOT HAVE PARTICIPATED IN THE COMMON LAW ADMISSION TEST].

4. Categories

Two different categories of applicants will be considered for admission under NRI/OCI Quota as indicated below:

Category-I: NRI/OCI parent

The Parent (Father or Mother) of candidates seeking admission should be a NRI/OCI.

Category-II: NRI/OCI Guardian

If the candidate has no parent where he/she has been taken as a ward by a near relative or someone and such NRI/OCI guardian has been legally declared as the guardian of the candidate by the Court as per the provision of Guardians and Wards Act, 1890.

NOTE:

i) In each and every category, candidates will be selected based only on interse merit.

5. Documents to be furnished

Candidates applying under NRI/OCI quota must furnish the attested photo copies of the following documents along with the filled-in application:

- a) NRI/OCI status certificate issued by the Indian Embassy of the respective country with seal. Certified true copy of OCI card in case of OCI category.
- b) Copy of the NRE (Non Resident External) or NRO (Non Resident Ordinary) Bank account pass book of the NRI/OCI.
- c) Copy of the valid Passport of the NRI/OCI. (OCI card issued by competent authority)
- d) Certificate of relationship (between the NRI/OCI (Guardian) and the candidate issued by the competent Authority)
- e) Employment Certificate of the NRI/OCI. [In case of Self-Employment, nature of the business, annual income and required proof of Income-Tax payment(for the last 3 years)]
- f) Qualifying mark / Grade list of the candidate

- g) Certificate showing that the candidate has proficiency in English language.
- h) School/College Transfer Certificate or (Migration Certificate and character certificate wherever necessary).

If the candidate fails to furnish any of the above documents, TNNLS reserve the right to reject the application.

The candidates provisionally selected under NRI/OCI quota will be admitted only after verification of all original documents. They should surrender all the original certificates at the time of admission for verification. On the date of admission, if any candidate fails to produce all the original certificates referred above he/she will not be considered for admission and provisional admission granted will be withdrawn. Extension of time will not be given for producing the original certificates.

On verification, if any discrepancy is noticed between information furnished in the application form and original documents produced, the selection will be cancelled.

Tamil Nadu National Law School, reserves the right to cancel the admission of any candidate for valid reasons.

6. Fee Structure
